# **Executive Leadership Development Programme**



#### Leadership Challenges For CFOs: Understanding Mindsets & The Social Capital

The Executive Leadership Development Programme begins by addressing the complex transition to senior leadership – both from a personal standpoint and within the broader organisational landscape. Participants will gain actionable strategies and frameworks to navigate this shift with clarity, confidence, and agility. They will also explore the psychology of power and influence, learning how to lead effectively even without formal authority. The session also highlights the importance of social capital, offering strategies to build and leverage professional networks to drive impact and get things done.

#### Leading High Performance Teams in Volatile Environments

Collaboration is at the heart of high-performing teams and the ability to drive it effectively is a core leadership skill. This session is designed to help leaders strengthen their capacity to foster alignment, guide group direction, and implement decisions that elevate team performance. Participants will explore how to make informed, strategic decisions by leveraging effective communication flows - whether from senior leadership, peers, or team members. The session will provide practical frameworks to help leaders identify relevant information, cut through noise, and build decision-making processes that are transparent, inclusive, and results-driven.

#### The Everest Simulation

The group-based exercise allows participants to observe their own behavior in a situation where leading others and teams is a key success factor. Participants will gain valuable insights and skills that can be applied in real-world, team-based, and leadership situations in the following areas:

- Develop effective teamwork and collaboration skills by emphasising trust, communication, and cooperation among participants in a challenging environment.
- Enhance decision-making abilities under pressure and limited resources, emphasising risk assessment and prioritisation of objectives.
- Cultivate leadership skills and adaptability by experiencing the responsibilities of leading a team in dynamic and uncertain conditions, and motivating team members to achieve shared goals.



#### **Senior Executive Group Coaching**

Participants break up in small peer groups during the coaching day. The support provided by the coaches and the group allows to link feedback results to their actual challenges. Participants will get to practice coaching themselves in a climate of trust. They make a pledge for change, work on their Individual Development Plan (IDP) and commit to concrete follow up actions.

Through the Hogan Assessment, participants will gain deep insights into their leadership style, interpersonal tendencies, and potential derailers that can impact team collaboration and decision-making. By understanding how their personality influences team dynamics, participants will be better equipped to build trust, manage conflict, and lead with greater self-awareness.



#### Managing Stakeholders Across the Organization

Both anecdotal evidence and decades of research have shown that power can dramatically impact the way we think, feel, and behave—in ways we do not expect.

Using a Power and Influence simulation, participants will delve into the dynamic world of organisational change. This session will illuminate the intrapersonal and interpersonal effects of power. Through understanding the psychology of power, you will learn practical and useful practical skills that will help you navigate and manage power dynamics in organisations. These skills will allow you to lead effectively, regardless of where you are in your career trajectory.
