

## ICT-02-2026 - Procurement of 38 Laptops

The purpose of this invitation to quote (ITQ) is to invite vendors to submit their quotations for 38 units of Lenovo laptops. This procurement will be split into **three orders**; first order in Q1 (Jan 2026 to Mar 2026), second order in Q2 (Apr 2026 to Jun 2026) and third order in Q3 (July 2026 to Sep 2026); total to 38 units. We will require three invoices for the respective three orders.

### 1. Scope of Work

Institute of Singapore Chartered Accountants (ISCA) is looking to purchase 38 units of Lenovo T14S Gen 6 laptops of the following model.

Two separate quotations sent to us must be complete and itemised with pricing for each line item. Vendors are to provide a quotation for the following items

If the laptops are not available, the estimated lead time of the laptop must be provided upon submission of the quotation.

Quotation submitted must be valid for 30 days until 13<sup>th</sup> February 2026.
