



# Guide to Reading the CPE Compliance Summary Table

Members are required to comply with CPE requirements and declare their CPE compliance status annually. Please follow the guide below on how to read the CPE Compliance Summary Table in the ISCA eServices Portal.



CPE Compliance at a glance



At the CPE Compliance Summary Table, choose the relevant triennium period. By default, the dashboard will show the current triennium period.

The "Hours Capped" column: As hour achieved in excess of each CPE year's requirements cannot be carried forward\* to subsequent years, this column shows the total verifiable hours capped for the selected period. E.g. (for CA (Singapore), if 27 verifiable CPE hours were to be clocked in 2018, the hours will be capped at the required hours for the year, i.e. 20 verifiable hours.

The "Outstanding" column shows your outstanding verifiable hours for the selected period. The outstanding hours are computed using "Hours Capped" less "Exempted" for each CPE year. See below illustration for more information.

Although the "Outstanding" balance is shown for the selected triennium period, this amount is calculated on a yearly basis.

In the example below, the "Outstanding" is not a direct computation of total hours of "Required" (60) less "Hours Capped" (25) less "Exempted" (40). This is because the 40 Exempted hours were for CPE years 2018 and 2019 and there is still an outstanding balance for 2020. As a general rule, hours clocked in excess of each CPE year's requirements cannot be carried forward to subsequent years.

## **Computation of Outstanding CPE Hours**

Although hours clocked in excess of each CPE year cannot be carried forward to the next, hours clocked in the current CPE year(s) could potentially be used to offset the shortfall in prior years.

In the example below, the 2019 CPE hours could be used to make good the shortfall for CPE years 2018 and hence there were no outstanding hours for the 3-year period.
