Why Accountancy? Video Contest
Terms and Conditions

The contest will be open for submissions on **5 August 2019** and all submissions must be received by ISCA by 12 noon on **16 September 2019** (deadline). ISCA will not accept submissions received after the specified deadline.

Please read these Terms and Conditions carefully before making a submission. By participating in the Contest, you indicate your agreement to the Terms and Conditions and confirm that you are at least 18 years of age. If you do not agree or are below 18, please do not participate.

Submission Requirements

1. ISCA is not liable for any computer or transmission errors or delays, including lost, late, or misdirected submissions, website errors, printing errors, server unavailability, computer, or any other electronic malfunction.
2. All submissions must be fully prepared and produced by the entrant(s). A submission may be disqualified from the contest should the submission be outsourced to a company or professional individual(s) for completion or enhancement.
3. Individual entrants must provide proof that they are enrolled in an accountancy course at the relevant university, such as their university matriculation card. For team submissions, at least one of the entrants must provide proof that they are enrolled in an accountancy course at the relevant university, and the other team members must provide proof that they are enrolled at the same university.
4. The submission must be an original work and solely created and authored by the entrant(s). It must not infringe upon the copyright, trademark rights or any other intellectual property rights of any person or entity or give rise to any liability on ISCA to pay royalties or other compensation.
5. Submissions must not contain any immoral, offensive, religious, discriminatory, scandalous, tortious, obscene or pornographic material, threatening or defamatory statements about any person, company, organisation or entity, must not infringe the privacy or other rights of any person, company, organisation or entity, and must not in any other way violate any applicable laws and regulations or expose ISCA to any civil or criminal proceedings in any part of the world.
6. The submission must not contain any viruses, Trojan horses, worms, bots, spyware, keystroke loggers, rootkits, backdoors or any other software or computer code that is intended or able to or does damage, interfere with and/or intercept or expropriate any system, data or information.
7. Information collected from all Entrant(s) is covered by ISCA's Privacy Policy at [ISCA Privacy and Data Protection Policy](#). You consent to ISCA collecting, using and disclosing all personal data that you submit to ISCA in the course of participating in

this Contest in accordance with ISCA's Privacy Policy and these Terms and Conditions, for the purpose of:

- a. administering this Contest; and
- b. publicizing and promoting the accountancy profession, ISCA and ISCA programmes.

You also consent to ISCA publicly announcing your name on its website and social media platforms should your submission be selected as a winner.

8. All submissions shall only be used for entry to the Contest and for no other purpose. ISCA reserves the right to disqualify submissions that have been or are being used for other purposes, including promotional activities that are not related to ISCA and/or the Contest.
9. ISCA reserves the right to reject or disqualify any submission that does not meet the criteria in Paragraph 5, does not comply with these Terms and Conditions, or otherwise on any grounds as ISCA may in its sole discretion decide.
10. In the event that you breach Paragraphs 10, 11 and/or 12, you will at your own costs indemnify, keep harmless and defend ISCA from and against any and all losses, damages, claims, costs, expenses, demands and/or liabilities arising from such breach.

IP Ownership, Publicity and Promotion

11. All intellectual property rights subsisting in your submission shall vest in and be owned solely by ISCA. In consideration of ISCA accepting your participation in this Contest, you hereby assign to ISCA absolutely any and all rights you may have in your submission, whether now subsisting or arising in the future. To the extent that any intellectual property rights in your submission may vest in you despite the foregoing provision, you hereby agree to assign to ISCA such intellectual property rights absolutely. For the avoidance of doubt, ISCA as owner of the rights in your submission will be entitled to reproduce, adapt, publish, upload, transmit, communicate, disseminate and otherwise deal with your submission and/or any part thereof, through any form or medium and for any purpose whatsoever. Without limiting the generality of the foregoing, your submission may be reproduced, adapted, modified, combined with other submissions, distributed and made available by ISCA for publicity and marketing purposes, in its full discretion.
12. You agree that you have the right to assign ISCA the intellectual property rights as contemplated in paragraph 17, and that ISCA shall have and shall enjoy quiet use and possession of such intellectual property rights.
13. You consent to ISCA, its principals, agents, representatives, successors and/or assigns using and disclosing your name, photographs and/or particulars with respect to your submission, in relation to ISCA and its associated programmes in any manner and in any media and formats in perpetuity throughout the world as ISCA deems fit, including for publicity and promotional purposes. The foregoing consent extends to the use and disclosure of all personal data included in your submission,

including the personal data of other persons who may be featured in your submission, and you confirm that you are authorized to provide this consent on behalf of such other persons.

Judging and Selection

14. After the close of submissions, three (3) winners (Top Prize, 1st Runner-up, 2nd Runner-up) may be selected by a judging panel from among all valid submissions, provided that ISCA may decide not to award any or all of the top three prizes if no submission meets its criteria for such prize. In addition, a Merit Prize will be given to the winning submission from each university. The remaining submissions will receive a Participation Prize.
15. The selection of the judging panel and the judging process shall be at ISCA's sole and absolute discretion. Each entrant shall accept and abide by any and all decisions made by ISCA including and not limited to, these Terms and Conditions, evaluation criteria and the awarding of prizes. No enquiries, appeals, verbal or written, shall be entertained.
16. All decisions made by the judging panel are final, binding and conclusive and will not be open to challenge on any grounds. ISCA and the judging panel have no obligation to provide reasons for any decisions.
17. The submission which attains the Top Prize may be adapted by ISCA for its promotional campaign, at ISCA's sole discretion. ISCA may decide not to use any of the submissions for its promotional campaign.

The Prize(s)

18. The top three prizes are vouchers amounting to the following:
 - a. Top Prize: SGD1,500
 - b. 1st Runner-up: SGD800
 - c. 2nd Runner-up: SGD500
19. Each winner or team leader of the winning submission will be notified by email or phone call. Before claiming the prize, the winner must provide his/her correct name, address and telephone number to ISCA at the time of notification. Within fourteen (14) days of notification, each winner must present him/herself at ISCA House (60 Cecil Street, Singapore 049709) to claim his/her prize in person and sign and return a release and affidavit of eligibility. Each winner must show proof of identification to claim his/her prize. ISCA reserves the right to examine additional identification and may choose to refuse to release the prize if it is not satisfied that the person claiming the prize is indeed the prize winner.
20. If a winner cannot be notified within fourteen (14) days of ISCA's first attempt to notify him/her, or does not sign and return the release and affidavit of eligibility in a timely manner, or ISCA is unable to verify his/her identity to ISCA's satisfaction, then that winner will forfeit his/her prize, and the prize may be awarded to the next winner with a valid submission, who will be determined in ISCA's sole discretion.

21. ISCA reserves the right to rescind any award, require any prizes to be returned to it and/or to disqualify any winning submission, in the event that a winner is found to have breached any of these Terms and Conditions.
22. All entrants other than the winners will receive a Participation Prize consisting of a gift voucher worth SGD10 (one prize per submission only, so a team will only receive one voucher). To claim a Participation Prize, entrants must show proof of identification to ISCA's satisfaction.
23. There will be no substitutions for any prize except at the sole discretion of ISCA. ISCA has the right to substitute any prize for a prize of similar value in its sole discretion. No transfer or assignment of prizes is allowed
24. In event of a tie in the results, ISCA reserves the right to redistribute the prizes.
25. The use of all voucher prizes is subject to acceptance by the provider of such vouchers. ISCA is not liable if the provider of any voucher fails to satisfy its obligations to accept or honour the voucher.
26. ISCA is not liable for any loss, damage, costs or expenses arising directly or indirectly from the award or use of the prizes.
