Application process for ISCA-CIMA Pathway



STEP 1

Candidate completes the registration form and submits CV, highest academic document and ID/passport online at www.cgmaonline registration.com



STEP 02

Candidate registers as a CIMA student and files application for CIMA membership.



STEP

Candidate attends a workshop to prepare for the CIMA Strategic Case Study exam, and sits for the exam.



STEP 04

CGMA & CIMA MEMBERSHIP awarded upon passing the Strategic Case Study exam and successful CIMA membership application.

Selection criteria

- ▶ Only open to ISCA members who are CA (Singapore) with 3 years full membership.
- Candidates must be based in Singapore.
- ► Candidates must fulfil CIMA membership criteria and pass CIMA interview.

Programme criteria

- Candidates must submit a detailed Curriculum. Vitae (CV) with:
 - Personal details
 - Academic and professional qualifications
 - Detailed work experience
- ► All related work experience submitted for CIMA membership must be filed before attempting the CIMA exam.
- The CIMA exam must be attempted within 12 months from the date of registration as a CIMA student.
